The competent authority, after considering the report, has been pleased to grant provisional affination for the session 2016-17 for the existing courses with earlier sanctioned intake, i.e., B. Tech. CE (60 seats), B. Tech. CSE (120 seats), B. Tech. ECE (120 seats), B. Tech. ME (60 seats), M. Tech. in CSE (24 seats), M. Tech. in ECE (24 seats), M. Tech. in ECE (Part-Time) (24 seats), BBA (120 seats) and MBA (60 seats) for the session 2016-17. Further, the competent authority has also granted temporary affiliation for new course i.e. BCA (60 seats) for /from the academic session 2016-17 subject to the deposit of Affiliation Fee worth Rs. 2.5 Lakhs for BCA course and fulfiliment of the deficiencies pointed out by the inspection committee. A photocopy of the inspection report dated 21.12.2016 is enclosed herewith for necessary compliance. The compliance report (alongwith all supporting documents/proofs such

as bills of materials/items procured, photographs/maps of facilities created, etc.) be submitted within a period of 15 days.

Further, as your Institute started the BCA course without the prior permission of the University; you are advised not to repeat such lapse / action in future, failing which a strict action shall be taken against your Institute as per Statute-39 of the University.

The above temporary affiliation for the existing UG/PG courses with earlier sanctioned intake is further subject to the condition that the institute will make full compliance of the provisions laid down in the Statute, Ordinance and the decisions taken by this University from time to time. Further, it is made clear that in the event of non compliance / fulfillment of the prescribed conditions / requirements, the University shall have the right to withdraw / refuse the provisional affiliation to the institute in the next academic session and all responsibilities arising due to such refusal / withdrawal would solely be that of the said institute / trust.
